

Power of Attorney Revocation Letter

To assist you in revoking a Power of Attorney (POA), Navy Federal provides the Power of Attorney Revocation Letter (Form 116) for your convenience. Please complete all relevant sections of the form and return it to Navy Federal as soon as possible.

Important Information:

- You may revoke a Power of Attorney at any time. However, the Attorney-In-Fact (AIF) will still have authority to act on your Navy Federal
 accounts until we receive official notice of the revocation.
- Verbal revocation is allowed by calling 1-888-842-6328, but it must be followed by written confirmation submitted to Navy Federal.
- It is your responsibility to inform your AIF that their authority has been revoked.
- The revocation becomes effective upon receipt by Navy Federal and is final. Once revoked, the Power of Attorney cannot be reinstated.
- If you have granted Trusted User Access for Online Banking, this revocation does not automatically cancel that access. To revoke Trusted User Access, please contact Navy Federal directly and submit a separate request.
